


Futurepark Property Fund "FUTUREPF"

Performance Summary

FY2008 Performance: The Fund had Net Investment Income of Baht 480.9 million, which was 1% higher than projection* and increased 7% compared to the same period of last year. The Fund also announced a dividend payment for FY2008 of Baht 1.021 per unit, which was 2% higher than projection and increased 5% compared to the same period of last year. The FY2008 dividend equals to the rate of return of 10.21% (Annualized)**

NAV increased 6.0% from IPO price. As of December 31, 2008 the Fund had Net Asset Value of Baht 5,015.9 million or Baht 10.5974 per unit.







Management Discussion & Analysis

Total Income

FUTUREPF showed total income in FY2008 of Baht 664.1 million, below 4% comparing to FY2008 projection of Baht 688.4 million and increased 1% compared to the same period of last year, which total income was Baht 659.2 million.

Total Expenses

Total expenses for FY2008 were Baht 183.2 million, below 13% comparing to FY2008 projection of Baht 211.2 million, and decreased 12% compared to the same period of last year, which total expenses were Baht 209.3 million because of decreased property expenses.

Net Investment Income and Distribution Income

In FY2008, FUTUREPF recorded net investment income of Baht 480.9 million, which exceeded 2008 projection by 1%. Distribution income for this year performance equaled to Baht 483.3 million, which exceeded 2008 projection by 2%. Distribution income equaled to Baht 1.021 per unit.

Net investment income increased 7% compared to the same period of last year, which net investment income was Baht 449.9 million. Distribution income increased 5% compared to the same period of last year, which distribution income was Baht 458.6 million. In FY2007, distribution income equaled to Baht 0.969 per unit.

Balance Sheet

Total assets of FUTUREPF equaled Baht 5,348.2 million, and total liabilities of Baht 332.3 million, comprising deposits received from tenants and other account payables. Net asset value (NAV) totaled Baht 5,015.9 million, equaled to NAV per unit of Baht 10.5974, increasing 1% from December 31, 2007.

Profitability

In FY2008, FUTUREPF showed net investment income margin of 72% of total income and distribution income margin of 73% of total income, which are higher than 2008 projection and the same period of last year.

Renovation of Rental Space and Capital Expenditure

In 4Q2008, FUTUREPF continued renovating their rental space in compliance with the marketing concept of The Natural - Metro Shopping Park. Total capital expenditure in this quarter was Baht 73.6 million. At the end of 4Q 2008, the renovating projects have been completed 96%.



2.Traffic Performance




Under the Natural-Metro Shopping Park concept adopted since the end of March 2008, together with the continuous marketing activities and sales promotions, the Future Park Rangsit shopping center saw a continuous increase in regular customer visits by approximately 21 percent, when compared with the corresponding period of the year before (April - December). 
